1	Income Tax Department	22-01-2025	Demand has been raised pursuant to intimation under section 143(1) on account of non-allowance of MAT credit by CPC, comprising Income Tax of INR 7,342,860. The Company filed rectification applications under section 154 with CPC on 26-02-2025, 11-06-2025, and 26-06-2025; however, in all the aforesaid rectification requests, CPC failed to grant the eligible MAT credit and did not rectify the outstanding demand. Thereafter, the Company approached the jurisdictional Assessing Officer, Circle 7(1), CR Building, ITO, New Delhi, by filing an application for rectification under section 154 on 31-07-2025.	As on 31st December, 2025 there was no Change. However the Income Tax Department, after examination of the facts and submissions made by the Company, has passed an order whereby the original tax demand amounting to ₹73,42,860/- has been substantially reduced to ₹4,09,813/-. The reduction primarily relates to relief granted by allowing MAT credit under section 115JAA and correction of assessed income. The said order was received by the Company on 27 January 2026.
2	Income Tax Department	31-12-2025	Outstanding TDS default demand amounting to INR 288710 is reflected on the TRACES website for the period from 2016 on account of short payment, short deduction, interest, late filing fee Default. The Company is in the process of filing rectification returns for the respective periods to resolve the said demand.	Outstanding TDS default demand amounting to INR 321740 is reflected on the TRACES website for the period from 2016 to till date.
3	GST Department	26-06-2025	Show Cause Notice No. 15/2025-26 was issued under section 74 proposing a demand of Tax amounting to INR 24,66,000. The Company duly filed its reply to the said Show Cause Notice on 21-07-2025. Subsequently, the adjudicating authority passed the demand order under section 74.
